#### **RESOLUTION 17 of 2024**

#### **A RESOLUTION TO SET A PUBLIC HEARING FOR THREE LOCAL LAWS ON FEBRUARY 26, 2024, AT 7:00PM:**

- **INTRODUCTORY LOCAL LAW NO. 1 OF 2024 ENTITLED "A LOCAL LAW TO PROVIDE A REAL PROPERTY TAX EXEMPTION FOR MEMBERS OF VOLUNTEER FIRE COMPANIES AND VOLUNTEER AMBULANCE SERVICES."**
- **INTRODUCTORY LOCAL LAW NO. 2 OF 2024 ENTITLED "A LOCAL LAW TO PROVIDE A REAL PROPERTY TAX EXEMPTION FOR UN-REMARIED SURVIVING SPOUSES OF FORMERLY ENROLLED MEMBERS KILLED IN THE LINE OF DUTY."**
- **INTRODUCTORY LOCAL LAW NO. 3 OF 2024 ENTITLED "A LOCAL LAW TO PROVIDE A REAL PROPERTY TAX EXEMPTION FOR UN-REMARIED SURVIVING SPOUSES OF FORMERLY ENROLLED MEMBERS WITH MORE THAN 20 YEARS OF SERVICE TO VOLUNTEER FIRE COMPANIES OR VOLUNTARY AMBULANCE SERVICES."**

**WHEREAS**, the local laws are as follows:

- Introductory Local Law No. 1 of 2024 entitled "A Local Law to provide a real property tax exemption for members of volunteer fire companies and volunteer ambulance services."
- Introductory Local Law No. 2 of 2024 entitled "A Local Law to provide a real property tax exemption for un-remarried surviving spouses of formerly enrolled members killed in the line of duty."
- Introductory Local Law No. 3 of 2024 entitled "A Local Law to provide a real property tax exemption for un-remarried surviving spouses of formerly enrolled members with more than 20 years of service to volunteer fire companies or voluntary ambulance services."

**RESOLVED**, that these Local Laws will be heard at a Public Hearing on February 26, 2024 at 7:00 pm.
