1. Inter-municipal Agreement between Town and Village - Erie Street Park Project

RESOLUTION 66 of 2025

A RESOLUTION TO ACCEPT AND ALLOW THE MAYOR TO SIGN THE INTER-MUNICIPAL AGREEMENT BETWEEN THE TOWN OF GOSHEN AND THE VILLAGE OF GOSHEN FOR THE IMPROVEMENTS OF ERIE STREET PARK

WHEREAS, an inter-municipal agreement (IMA) has been developed with both the Town of Goshen and Village of Goshen agreeing to the terms; and

NOW, THEREFORE, IT IS HEREBY,

RESOLVED, that the Village of Goshen agrees with the conditions of the IMA between the Village of Goshen and the Town of Goshen as it relates to the improvements of Erie Street Park:

2. Clarifier Rehabilitation Project - Change Order #2

RESOLUTION 67 of 2025

A RESOLUTION TO APPROVE THE MAYOR TO SIGN CHANGE ORDER #2 FOR THE CLARIFIER REHABILITATION PROJECT FOR A COST OF \$24,764.40

WHEREAS, the Village of Goshen has awarded the Clarifier Rehabilitation Project to TAM Enterprises; and

WHEREAS, the following changes are being made to the Contract Documents: replace the existing non-functioning gear drive operator for the scum trough with manual operation levers, and replacing worn out bearings in the scum trough assembly in both clarifiers; and

NOW, THEREFORE, it is hereby

RESOLVED, that the Mayor be authorized to sign Change Order #2 for the clarifier rehabilitation project with a total cost of \$24,764.40, which is covered by the \$40,000.00 stated allowance for unforeseen items on the Contract Bid Form.

3. Dedication of Streets

RESOLUTION 68 of 2025

A RESOLUTION ACCEPTING THE PUBLIC IMPROVEMENTS OF COLT COURT, PACER COURT, CORRAL LANE, BRIDLE COURT (EAST AND WEST)

WHEREAS, the subdivision known as "Harness Estates" has heretofore received final subdivision approval from the Village of Goshen Planning Board; and

WHEREAS, the subdivision map for the Harness Estates subdivision has been duly filed in the office of the Orange County Clerk and construction has been undertaken regarding the public improvements required to be installed within the said subdivision; and

WHEREAS, the Village Board has heretofore accepted certain public improvements within the said subdivision; and

WHEREAS, the owner and developer of the Harness Estates subdivision now requests that the Village Board accept certain other public improvements required by the aforementioned subdivision map and establish the maintenance bond for the public improvements so accepted; and

4. Part-time Annual Salary Increase

RESOLUTION 69 of 2025

A RESOLUTION TO INCREASE THE HOURLY RATES FOR PART-TIME POSITIONS EFFECTIVE, JUNE 1, 2025, FOR THE FOLLOWING:

4% FOR POLICE OFFICERS, 3% FOR POLICE DISPATCHERS, CLERICAL, AND DPW SEASONAL LABORERS, AND A FLAT INCREASE TO \$24.00 PER HOUR FOR COURT ATTENDANTS

WHEREAS, at the June 23, 2025 Village Board Meeting, the hourly rates for part-time positions was determined, and are to be increased effective, June 1, 2025;

NOW, THEREFORE, IT IS HEREBY,

RESOLVED, the Village Board approves the hourly rates for part-time positions to be increased as follows, effective, June 1, 2025:

- Police Officers 4%
- Police Dispatchers 3%
- Clerical 3%
- Court Attendants Flat increase to \$24.00 per hour
- DPW Seasonal Laborers 3%

Mayor O'Donnell asked Chief Rich and Village Clerk Darby to discuss further to see if there are any changes needed in the Village Code, such as insurance requirements, other necessary documentation, and required time to notify the Village. Mayor O'Donnell asked Attorney Donovan to obtain the plan from the government center so it can be reviewed.
