1. Standard Work Day and Reporting Resolution for Elected and Appointed Officials

RESOLUTION 87 of 2025

ADOPTING A STANDARD WORK DAY AND REPORTING RESOLUTION FOR ELECTED AND APPOINTED OFFICIALS

WHEREAS, the Office of the New York State Comptroller requires that elected and appointed officials must have standard work days in order to determine the correct number of days worked to report to an official in order to obtain service credit for retirement benefits; and

The fee for each license issued pursuant to this article shall be \$150.00 quarterly or \$45.00 per day. The license fee may be changed by resolution of the board of trustees."; and
