Mayor Wohl called the meeting to order at 5:35 pm and led those present in the Pledge of Allegiance.

Items of Business

1. Modification to the Community Development Block Grant (CDBG) Application

RESOLUTION 85 of 2026

A RESOLUTION AUTHORIZING THE RESUBMISSION OF THE ORANGE URBAN COUNTY CONSORTIUM COMMUNITY DEVELOPMENT PROGRAM APPLICATION FOR FISCAL YEAR 2027 AND AUTHORIZING THE APPROVAL OF THE ADDITIONAL COST OF \$2,800.00 FOR LANC & TULLY TO RESUBMIT THE APPLICATION AND PREPARE A PLAN TO BE INCLUDED WITH THE RESUBMISSION

WHEREAS, the Village of Goshen is hereby submitting its Application for consideration under the FY-2027 Orange Urban County Consortium Community Development Program; and

WHEREAS, input from citizens and groups has been solicited and considered at a public hearing and an application has been prepared which addresses any community concerns; and

WHEREAS, the Village Board further certifies that they have read and understand the Orange Urban County Consortium Community Development Guidelines for the FY-2027 program year and have met all of its applicable requirements and that the information contained in the Application is accurate and true to the best of their knowledge; and

WHEREAS, if awarded CDBG funds, the Village of Goshen shall implement the activities in a manner to ensure compliance with all applicable federal, state and local laws and regulations,

NOW THEREFORE, IT IS HEREBY RESOLVED, that the Village of Goshen authorizes Village Mayor, Scott Wohl to resubmit this year's CDBG application for Sidewalk Replacement, and to include the installation of four solar powered crosswalk signs, that includes the Villages Planner, Lanc & Tully, to prepare a plan with required specifications for the NYS DOT permit; and it is further

RESOLVED, that the Village Board approves the additional estimated cost of \$2,800.00 to resubmit the CDBG application, which also includes preparing a plan with required specifications for the NYS DOT permit.

2. Authorizing the Village of Goshen to participate in the Orange County Employment and Training Administration Summer Youth Program

A RESOLUTION ALLOWING THE VILLAGE OF GOSHEN MAYOR TO SIGN AN AGREEMENT TO PARTICIPATE IN THE ORANGE COUNTY EMPLOYMENT AND

TRAINING ADMINISTRATION SUMMER YOUTH PROGRAM FOR THE SUMMER OF 2026

WHEREAS, a summer youth program has been developed; and

WHEREAS, the Village of Goshen has been invited to participate in the program; and

WHEREAS, specifics of the program include,

- no cost to the Village;
- children are supervised by Orange/Ulster BOCES staff up to 30 hours per week, for up to eight weeks;
- and children will be reporting to DPW Superintendent Bryan Morgiewicz for their assignments including painting and landscaping.

NOW, THEREFORE, it is hereby

RESOLVED, that the Village of Goshen Mayor is hereby authorized to sign the agreement allowing the Village of Goshen to participate in the program.
